REGISTRATION OF OVERSEAS BIRTH

Important information for applicants

- This form is for PNG Citizens seeking to register the overseas birth of their child for the purposes of Citizenship. This must be undertaken within 12 months of the child's birth. The definition of 'child' refers to both biological and legally adopted children. This does not include customarily adopted children or children for which you may have guardianship.
 - Note the Minister **may** allow applications to be made after 12 months from the date of birth of the child (*Citizenship Act*, Section 5(2)). If you seek to access this provision for an overseas born child aged older than 12 months but younger than 18 years, attach a detailed statement of facts and reasons why you wish this discretion to be exercised to this application form.
- The application must be completed by a parent who is currently a PNG Citizen.
- There is no application fee to register an overseas birth.
- You need to ensure your application is completed in full and all supporting documents are included when you lodge your application. If an application is found to be incomplete then the application will be returned.
- You need to carefully check your application and support documents for accuracy as false or misleading information can result in severe penalties.
- Your signature on the application must be witnessed by an Authorised Officer:
 - For applicants residing in PNG this is a Magistrate or Court Official from the National/Provincial/District Court House, or a qualified Legal Officer, with a Commissioner of Oaths title. The Authorising Officer must also provide a copy of his/her identification (passport bio data page, drivers licence, employee ID card etc).
 - For applicants residing overseas this is an official from a PNG Embassy, High Commission or Consulate, or any accredited public notary or justice of the peace within the country where the applicant resides.
- The Authorised Officer is also required to sight your original identity documents and certify a copy of those identity documents. They are also required to confirm that the application photo is a true likeness of you.
- Birth Certificates of parent(s) if a P NG Birth Certificate, note the previous "blue hard cover' Birth Certificates are no longer acceptable forms of identity by PNG Immigration and Citizenship Service Authority. If you are a holder of the old style Certificate you will need to obtain a new birth Certificate before lodging this application.
- Birth Certificate of the child must be the birth Certificate from the country in which the child was born.
- If you have any questions regarding Citizenship or wish to make an appointment to discuss your circumstances, prior to lodging an application, please contact us: Citizenship@immigration.gov.pg or via our client service counter at the Central Government Office Waigani (Monday to Friday 9am-12pm).

- You or your representative can lodge your application at the Central Government Office Waigani (Monday to Friday 9am-12pm). At the time of lodgement you will receive an application receipt. Please keep a copy of your application and the lodgement receipt for future reference.
- Alternatively, you or your representative can lodge your application by mail to:

- If overseas, you may lodge your application at the nearest PNG Embassy, High Commission, or Consulate.
- Within 5 working days of receiving the application you (or your representative where requested) will be issued with an email acknowledging receipt. Please keep a copy of your application and the email acknowledging receipt of the application for future reference.
- If you are seeking PNG Citizenship for your biological or adopted child who is over 12 months old you may wish to consider the Citizenship by Descent pathway.

For future reference

- PNG Citizens under 18 years can lawfully hold dual Citizenship with another country(s). They cannot seek approval from the PNG Government to hold dual Citizenship before they are 18 years old.
- PNG Citizens aged between 18 and 19 years, who already hold dual Citizenship are required to:
 - 1. Renounce Citizenship of the other country(s) for which they hold Citizenship; or
 - 2. Seek approval by the PNG government to hold dual Citizenship with a prescribed country, currently Australia, Fiji, Germany, New Zealand, Samoa, United Kingdom, United States of America or Vanuatu; or
 - 3. Renounce their PNG Citizenship.

PNG Citizenship is automatically lost if options 1 or 2 are not completed by the age of 19 years.
